**Introduction:** The Central Government has decided to set up state level residential schools for tribal students from the funds disbursed under Article 275

(1) of the Constitution of India in the Ninth Five Year Plan for the purpose of providing quality education to the students of Scheduled Tribes. As per Tribal Development Department Government Resolution dated 11th September 2000, in the first phase in the tribal sub-plan area of the state from the year 2000-01 for tribal students 1) Nashik (Nashik) 2) Kambalgaon (Thane) 3) Chikhaldara (Amravati) 4) Central Secondary at Khairiparsoda (Nagpur) According to the syllabus of Shiksha Board, New Delhi, Eklavya Niwasi Sha has been started with English medium classes from 6th to 12th. Also, for these schools, teachers / teaching staff and their salaries are There are currently 16 Eklavya residential schools for tribal students. Among them, Charmoshi, Dist. Gadchiro Titway, Dist. The Tribal Development Department has not yet issued formal orders to these two schools in Nashik. The reason is that the grant received from the Central Government under Article 275 (1) of the Constitution of India as per the MAM principle received from the Central Government.
